



## Vancouver Municipal, Education and Community Workers Society CUPE Local 15 Dependent Bursary

An annual award of \$1000 is available to assist the sons, daughters and legal dependents of the members of CUPE Local 15. Recipients will exhibit academic proficiency and financial need and one or more of the following criteria:

1. The member upon whom the applicant is a dependent must be a current or retired member of CUPE Local 15 (excluding associate members). The member must have demonstrated a primary attachment to CUPE Local 15 by holding Union membership through a minimum of six months employment for each of the two years prior to the date of enrolment.
2. Must be enrolled in a full time program of six months duration or longer, commencing Fall 2012.
3. Award recipients will be selected based on academic achievement (attach Grade 12 transcript) and community involvement. Applicants must have a B average and include a letter of reference along with the award application form.
