- PLAR credit fees are assessed at a maximum of 50% of the current tuition rate of VCC courses. Payment must be received prior to PLAR assessment. If the PLAR request is approved, the Registrar's Office will update the student's official academic record accordingly. Students are advised to check their account summary online via their myVCC account. Outstanding account balances may impact future registration.
- In combination with approved transfer credits, the maximum credits obtained through PLAR will not exceed 65% of the total credit value of the student's program of study at VCC. Some programs may have different restrictions for maximum credits obtained through transfer credit and PLAR. Please refer to the Program Content Guide of your program for more details.
- Receiving PLAR credit(s) may reduce the number of courses required in a term, full-time program status and/or overall length of study. This may impact eligibility for financial assistance, scholarships, bursaries and awards. Students are strongly advised to consult with the Financial Aid Office (financialaid@vcc.ca) to learn how PLAR may impact their status and eligibility.
- Students must submit all requests for Prior Learning Assessment a minimum two weeks prior to the start of registration. PLAR will not be assessed or awarded once the course freeze date has passed.
