The program provides funding for exceptional and deserving students who identify as Black, Indigenous or Persons of Colour to help overcome financial barriers.

- Eligibility Criteria: 1. Enrolled in, or accepted to, a Culinary Arts, Baking and Pastry or Catering program
 - 2. Self-identification as a Black, Indigenous or a Person of Colour
 - 3. Demonstrated passion for the industry and leadership potential. Preference given to those in good academic standing
 - 4. Demonstrates non-academic overcoming barriers and challenges in the pursuit of their education; making a positive contribution to the classroom, college or community; volunteerism; industry-specific awards, training or employment
 - 5. Preference given to students with demonstrated financial need, as assessed by Financial Aid department
