

Dear Sponsoring Dentist,

Thank you for considering sponsoring a student in the Vancouver Community College (VCC), Certified Dental Assisting (CDA) Online Program. Each student is required to have a signed sponsoring dentist agreement indicating work experience, as well as an agreement to assist the student with access to the dental office environment and procedures. This sponsorship is confirmed on a regular basis; however, if the sponsorship of the students comes to an end, please inform the program immediately by sending an email to daddp@vcc.ca.

The program comprises 13 theory and three clinical courses delivered online and supported by a VCC CDA instructor. The courses include in-office activities and are designed to integrate theoretical concepts with clinical practice.

The minimum requirement for the program is 14 hours of clinical practice per week; however, this number can increase as the student gains more experience. Since the students are learning online, we look to the sponsoring dentist as a partner to provide the clinical setting for their hands-on learning, which greatly improves their success in the clinical courses. The student should spend most of their time performing chairside assisting, patient management, infection control and learning clinical procedures. As they progress through the theory courses, they will bring more skills and knowledge of "dental assisting practice" to enhance their participation in the dental office.

Following completion of Level 1 and Level 2 theory courses, clinical sessions, including the radiography clinical (resulting in a BC College of Oral Health Professionals (BCCOHP) Radiography Certificate) are held at VCC's downtown campus where students are evaluated on provincial competencies.

This program provides the interested individual an opportunity to learn and grow in the dental profession leading to an exciting and rewarding career as a CDA.
