- The status may change during the application evaluation process, and at any time without prior notice.
- Program seats will be available on a first-qualified, first-offered basis. Only qualified applicants may receive offers, and offers are not guaranteed.

- Application fees are non-refundable and will be assessed upon receipt of the application, regardless of students’ eligibility.
- Applications with missing documents or invalid application fee payment information may result in a delay in the application processing time.
- If an offer is issued, students must pay the tuition deposit by the payment deadline, which is usually given 2 weeks to pay after offer letters are issued.
- Applications will be withdrawn if tuition deposits are not received by the deadline. Students are required to pay application fees again to re-apply.
