



Sign Language Interpretation Diploma Program Interview & Video Submission Guidelines

Panel Interview

Applications will be reviewed by the selection committee. Selected applicants will be invited to attend an online interview.

Panel Interview Details:

- Applicants will be contacted to arrange an interview 1-2 weeks prior to Screening Week.
- Each interview will last approximately **1 hour**.
- Interviews will take place virtually via Zoom.
- Interview panels will include faculty and community members.

Post-Interview Video Submission

After the interview, applicants will receive instructions for a post-interview assignment. Assignments are due **4 hours after the interview concludes**.

Video Submission Requirements:

- Submit **2 videos 5 - 10 minutes** each – 1 using ASL and 1 using spoken English. Instructions for each video will be provided after the interview.
- **Platforms:** Record and upload videos to **YouTube**.
- **Labeling:** Videos must be labeled with your **student number, name, and video title**.

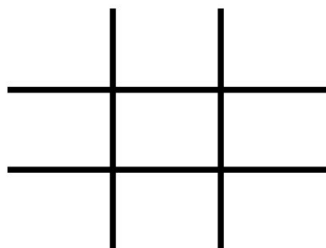


Recording Tips for Video Submission:

As future interpreters using a visual-gestural language, creating visually clear recordings is critical to receiving and providing feedback. Use these tips to produce high-quality videos:

Framing Tips:

- Ensure your face is in the **top third** of the frame, with a small space between the top of your head and the frame's upper edge.
- Ensure the camera is **parallel to your line of vision** (not angled up or down).
- Frame yourself to show the entire signing space – from your **lower torso to the top of your head** – to capture facial grammar and expressions clearly.
- Look for **horizontal and vertical alignment** (e.g., edges of doors or bulletin boards) to prevent tilted or skewed videos.
- Apply the **rule of thirds**: Position points or lines of interest at 1/3 or 2/3 of the frame for a balanced composition.





Clothing Tips:

- Wear **solid-coloured attire** that contrasts with your skin tone and background.
- Avoid visual distractions like **busy patterns, large jewelry, or flashy accessories**.
- Keep hairstyles simple and clear of your face to ensure maximum visibility of your signing.

Background & Lighting Tips:

- Use a **clean, uncluttered background** that is appropriate and distraction-free.
- Ensure you are **adequately front lit** to avoid shadows on your face and hands.
- Focus on creating **clear visibility of signing and facial expressions**.
- Ensure the sound is **audible** for spoken portions of the video.

Important Reminder:

Not meeting the above standards could result in your submission being returned and considered incomplete.
